# 2023 NETX HIP Progress

IOINT VENTURE



Habitat Accomplishment and Investment Over 23,000 acres and \$1,000,000

- 2022 RFP Streamlined Process worked well
   Anticipate \$180k \$240k annually
- New Payment Rates and Adjusted Map
  - Simplified Rates and Map on NETX Website
  - More changes in 2024 with Strategic Plan/Map

## **2023 RFP/HIP Timeline**

- Open April 17-21, 2023
- Close June 9
- Draft Ranking June 26
- Steering Committee
  - Convene to Approve
  - June 28

# 2023 Challenges – 63 Proposals!

- Requesting almost \$850,000
  - Funds available for only 20-25 projects
- Considerations
  - Reduce cap for 2024?
  - Negotiate lower rates on projects over \$20k?
  - Fund only known cooperators (maintain investment)
    - No new cooperator landowners?

#### Future options for "many good" unfunded projects:

- Reduce \$40,000 project cap, with limit to 1 ownership
  - o (LLC, Company cannot submit 3 projects)
- Restrict applicants with open projects
- $\,\circ\,$  Request funding for initial treatment
  - $\circ$  Only projects to be completed within 12-18 months
- Negotiate lower payments for proposals \$20-40k
- Alternative Options for small ownerships
  - $\circ$  (develop process to offer NRCS options)
- Alternative Options for projects outside priority
- Scoring criteria (pts fire 10 chemical 5 mechanical 0)
- Re-evaluate Priority Habitat Model & extend to all East Tx
- Notification to unselected projects with suggestions to improve
